



Your Plan Highlights at a Glance

Key Features of the Emeriti Program

Your institution has adopted a retiree health plan through the Emeriti Program, a comprehensive retiree health benefits solution for employees of colleges, universities, and other education-related nonprofit organizations. The three core components of the Emeriti Program include:

- **Emeriti Health Accounts** a tax-advantaged way for you to save and invest assets exclusively to help meet future retiree medical expenses. Services provided by Fidelity Investments.
- **Emeriti Health Insurance Options** a specially designed group retiree health insurance program for yourself and your eligible dependents that complements Medicare. Underwritten by Aetna Life Insurance Company.
- **Emeriti Reimbursement Benefit** a tax-free way to receive reimbursement for your and your eligible dependents' qualified out-of-pocket medical expenses. Managed by third-party administrator, Acclaris.

About Your Plan

You are a participant in the Emeriti Retiree Health Plan for Elaremont McKenna'Eqngi e. Under the Plan, your spouse or domestic partner, dependent children, and dependent relatives-- as defined by IRS guidelines-- may also be eligible to receive benefits while you are receiving benefits and may continue to do so after you die.

Your Employer's Contributions

Your Employer will begin making contributions for you when you reach age 40 and have completed 1 year of service. The amount of the contribution will be determined by the Institution. The Institution will cease making its contributions on the earliest of the following:

- the date the institution has made 25 years of contributions to your account
- the date you cease employment at the institution
- the date of your death during employement

Your Own Contributions

You can begin to make voluntary contributions from your payroll to the Plan on a flat dollar basis each payroll period. The amount will be determined by you, and there are no limits on the amount you can contribute. Your contributions will be made on an after-tax basis, but all contributions and earnings will accumulate and be paid out tax free for your retiree health insurance and other qualified medical expenses. You may also make personal after-tax contributions to your Emeriti Health Account from your bank account during active service, when you terminate, or even after retirement.

Your Eligibility for Emeriti Benefits

Using Your Emeriti Reimbursment Benefit

You will be able to utilize the Emeriti Reimbursement Benefit to pay for any qualified out-of-pocket medical expenses after termination of employment with the institution. See Emeriti's websites at www.emeritihealth.org (click on Emeriti Reimbursement Benefits at the bottom of the home page for a list of eligible expenses).

You have the right to use all of your own contributions and earnings, and any Employer contributions in your Health Account, to pay for qualified out-of-pocket medical expenses through the Emeriti Reimbursement Benefit after you leave the Institution.

If you have an account balance over \$5,000 you must wait until you leave the Institution and reach age 55 to begin using the contributions.

If you have an account balance less than \$5,000, you can start using the money in the account as soon as you terminate employment from your Institution for qualified medical expenses.

Please read your Summary Plan Description (SPD) for further details about special conditions allowing for early withdrawal of your Emeriti assets in the case of a terminal illness or a catastrophic health situation.

Using Your Emeriti Post-65 Health Insurance

You will also be eligible for the Emeriti Health Insurance Plan Options if you satisfy the criteria for Retirement Eligibility under the Plan:

- attained age 55 while employed by the institution with at least 10 years of continuous service
- attained age 65, in the case of late hires, with at least five years of credited service
- became permanently disabled during active service and received a disability determination letter from Social Security

Having met the criteria for Retirement Eligibility, you will be able to enroll in the Emeriti Health Insurance after terminating service with the institution, attaining age 65, and enrolling in Medicare Parts A and B.

If your spouse or domestic partner (if elected by your institution) is also age 65 or older and is enrolled in Medicare Parts A and B, he/she may also enroll when you do in the same Emeriti Health Insurance Plan Option you have elected. If your spouse or domestic partner or eligible dependents are not Medicare-eligible, they may enroll in Emeriti's pre-65 Health Insurance Plan Options when you enroll.

If you cease employment with the Institution without having met the criteria for Retirement Eligibility, you will not be able to enroll in the Emeriti Health Insurance Plan Options. You will be able to use the Emeriti Reimbursement Benefits if you have met the eligibility criteria defined in the Summary Plan Description (SPD).

Your Right to Emeriti Benefits

Subject to the rules of your Summary Plan Description (SPD), your Emeriti Health Account assets are available to pay health insurance premiums and other qualified medical expenses for your life and the lifetime of your eligible dependents. Once you have died and once all your eligible dependents have died (or reached majority, in the case of children), any remaining balance in your Health Account is forfeited back to the Plan for use under the terms of the Plan for other eligible participants of your institution.
