**SUMMARY ANNUAL REPORT FOR

This is a summary of the annual report of the The Claremont Colleges Health & Welfare Benefits (Employer Identification Number 95-4786748, Plan Number 522) for the plan year 01/01/2021 through 12/31/2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Claremont Colleges, Inc. has committed itself to pay certain medical, dental and vision claims incurred under the terms of the plan.

**Insurance Information**

The plan has insurance contracts with Anthem Blue Cross Life and Health Insurance Company, Kaiser Foundation Health Plan Inc, Unum Life Insurance Company of America, U.S. Behavioral Health Plan, California dba Optum, Zurich American Insurance Company, Cigna Health and Life Insurance Company, ARAG Insurance Company and ReliaStar Life Insurance Company to pay certain life, accidental death & dismemberment, medical, dental, vision, long-term disability, legal, business travel accident, employee assistance, accident, critical illness and hospital indemnity claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2021 were \$35,585,196.
